# ISR Hot Lunch Programme 2018 - 2019 Terms & Conditions

## **PAYMENT**

- Hot lunch price, per day/meal:
  - o PreSchool Grade 5: €3.45 per day/meal
  - o Grades 6 12: €4.20 per day/meal
- Hot lunch invoices will be sent by email each semester. Payments may be made ONLY by bank transfer within the payment terms indicated in the invoice.
  - Semester 1: 20 August 13 December, 2018
  - o Semester 2: 7 January 13 June, 2019
- No refunds are available for missed meals due to absenteeism.

## SUMMARY INFORMATION ABOUT THE HOT LUNCH PROGRAMME

- Students may choose a meat, vegetarian or vegan option.
- Specific allergies or other dietary requests can be accommodated with receipt of a doctor's note.
- The weekly lunch menu is posted each week in the campus canteens and on the ISR website (https://isriga.lv/services/lunch/).
- Each school hot lunch for <u>Preschool and Kindergarten</u> includes:
  - 1. Vegetarian soup
  - 2. One entree (meat/fish OR vegetarian OR vegan as per sign-up)
  - 3. One side dish (e.g. potatoes, pasta, rice, bulgur, couscous, buckwheat, etc.)
  - 4. One salad (mixed with a dressing; or plain vegetables with dressing aside)
  - 5. Warm or cold sauce (depending on the daily menu)
  - 6. One dessert (e.g. one of fruit salad, single fruit, curd snack, smoothie or a pastry)
  - 7. Drink (usually a fruit drink)
  - 8. Bread
- Each school hot lunch for <u>Grades 1 12</u> consists of:
  - 1. Vegetarian soup
  - 2. Choice of meat/fish entree (e.g. 2 different meat options OR 1 meat and 1 fish option) or
  - 3. One vegetarian/vegan entree

- 4. Side dish (2 options daily e.g. various potato dishes, pasta, rice, bulgur, couscous and buckwheat etc.)
- 5. Salad (2 options daily e.g. mixed with a dressing, plain vegetables with dressing aside)
- 6. Warm or cold sauce (depending on the daily menu)
- 7. Dessert (e.g. one of fruit salad, single fruit, curd snack, smoothie or a pastry)
- 8. Drink (usually a fruit drink)
- 9. Bread

- The Terms and Conditions for the ISR Hot Lunch Programme 2018 2019 are valid for the school year 2018 - 2019. Terms are subject to change and any updates will be shared with programme participants.

#### PROCESSING & DISCLOSURE OF PERSONAL DATA

- In order to deliver hot lunch services to students, the School collects the following data:
  - 1. Student first, last name
  - 2. Student grade, and class if applicable
  - 3. Student allergy information (if applicable)
  - 4. Student preferred dietary restrictions (if applicable)
  - 5. Parent contact email
- The personal data collected in regards to the ISR Hot Lunch Programme, including special category data, is for the purpose of:
  - 1. Providing individualized meals, as per request and/or doctor's order;
  - 2. Trying to prevent students from making improper food choices as per their dietary restrictions; and/or
  - 3. Ensuring prompt medical intervention in the case a student manifests allergic reactions, or to prevent such reactions.
- Data processing regarding a student's allergies or other preferred dietary restrictions may be shared with School teachers, Nurses, and cafeteria staff, as expressly laid down by Latvian National law and the European Union [Regulation (EU) 2016/679 (General Data Protection Regulation)], on the lawful basis that:
  - 1. processing is necessary in order to protect the vital interests of the data subject [Art.6, (d)]
  - 2. processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract [Art.6, (b)]
  - 3. processing is necessary for the purposes of the legitimate interests pursued by the controller or by a third party [Art.6, (f)]
- Personal data collected for the purposes of the ISR Hot Lunch Programme is held only for the duration of the Programme contract; after which time it is permanently destroyed.
